## FROM THE CHAIR

We are beginning the spring semester, and I am pleased to report that we have a record number of students (29) in our senior seminar this term. Growth is good, though we sometimes struggle with its consequences. Our classes are full enough that we will be able to hire another faculty member for next year, bringing us to twenty PhD economists. To put that in context, when I was hired in 1984, I was a new line that brought the department to nine.

This growth led us to take the department faculty and staff on its first retreat this January. We came away with a better sense of the department's mission to transmit, create and apply economic knowledge through our teaching, research and outreach, and older and newer faculty were able to transmit their experiences and their hopes. We are hoping to do that again in Spring 2008, when we will have nicer weather.

Our graduates are doing pretty well. I get email from some (and would like more!) and recently I got some data from a Career Services survey on recent graduates. For example, of the 39 majors we graduated in 2004-05, 23 are working in an economics-related field somewhere, three are in graduate schools, and three more are working but want jobs that use economics more. (The remainder are either at home, or seeking work, or could not be reached in the survey.)

Winter Institute is coming February 22-23. Rich MacDonald is working temporarily in New York City as vice president of the National Council on Economic Education, so Örn Bodvarsson is directing our own Center for Economic Education temporarily and running the Institute this year. We will arrange a room again for alumni who visit the Economic Outlook to get together. Hope to see you then!

## WINTER INSTITUTE & ECONOMIC OUTLOOK

The 45th Economic Education Winter Institute's theme is "Immigration and Globalization." The conference begins with the Economic Outlook, held on February 22 from 5 to 6:30 p.m. at the Kelly Inn, followed by a food and cocktail reception. It features Dan Laufenberg, Arthur Rolnick, Tom Stinson, and King Banaian, who will speak on national, state and local trends.

The speakers program the following morning features two international authorities on immigration – Richard Freeman of Harvard University and Barry Chiswick of University of Illinois-Chicago. Freeman will speak on the effects of immigration and Chiswick on immigrant skills.

## FACULTY

**Örn Bodvarsson's** paper, "The Political Market for Immigration Restrictions: Model and Test," (co-authored with Anton Lowenberg, William Kaempfer and William Mertens) was accepted for publication in the *Journal of International Trade and Economic Development*.

**Örn Bodvarsson** and Jack W. Hou have co-authored a chapter on Labor Economics, which will be part of a forthcoming *Handbook of Economics*, to be published by the University of Beijing and distributed to all universities in China during 2007.

**Örn Bodvarsson** presented a one-day workshop for bankers titled "The Microeconomics of Banking" in Topeka, Kansas in September, 2006. The workshop was sponsored by the Schools of Banking, headquartered in Lincoln, Nebraska.

**King Banaian's** paper, "Remittances in Armenia II: The Impacts of Remittances on the Economy and Measures to Enhance Their Contribution to Development," (co-authored with Bryan Roberts) has been published in the *Armenian Journal of Public Policy*.

**Örn Bodvarsson** is serving as a co-coordinator (with Abbas Mehdi of SCSU's Department of Sociology and Anthropology) of the "Globalization and Socio-Economic Development" section in the Society for the Advancement of Socio-Economics (SASE). Örn's primary responsibility is to organize the section's program at the annual SASE conference, which will be held in Copenhagen, Denmark in June.

**Örn Bodvarsson** was appointed a Research Fellow at the Institute for the Study of Labor (IZA), Bonn, Germany, for an initial period ending March 31, 2010.

**King Banaian** visited Armenia in January to attend the Armenian International Policy Research Group (AIPRG) conference. The conference topic, "The Economic and Social Consequences of Opening the Armenia-Turkey Border" brought together researchers, policymakers, international organizations, and other stakeholders to examine the potential benefits and costs of opening the border and normalizing relations between Armenia and Turkey. The conference was co-sponsored by USAID, Eurasia Foundation, and the UK Embassy in Armenia. Banaian is an AIPRG Research Fellow.

**Artatrana Ratha's** paper, "The Bilateral S-Curve between Japan and Her Trading Partners" (with Mohsen Bahmani-Oskooee), was accepted for publication in *Japan and the World Economy*.

**Artatrana Ratha's** paper, "Bilateral J-Curve: Sweden versus Her 17 Major Trading Partners" (with Mohsen Bahmani-Oskooee), was accepted for publication in the *International Journal of Applied Economics*.

**Artatrana Ratha's** paper, "S-Curve at the Industry Level - Evidence from US-UK Bilateral Trade" (with Mohsen Bahmani-Oskooee), is under revision in *Empirical Economics*.
