FROM THE CHAIR

WINTER INSTITUTE

The SCSU Center for Economic Education is very pleased to announce that the 47th Annual Economic Education Winter Institute will be held on Friday, February 27, 2009, from 9:00 a.m. to 11:15 a.m. in Ritsche Auditorium on the SCSU campus. The theme of the Winter Institute is "Sino-American Economic Relations" and features Wing Thyee Woo and Nicholas Lardy, two internationally known experts on the Chinese economy and its impact on the U.S. economy. The Winter Institute luncheon, held from 11:30 a.m. to 1:00 p.m. on February 27 in the Cascade Room at Atwood Memorial Center will feature a speaker, Jack W. Hou, also an expert on Chinese economic affairs.

The Annual Economic Outlook will be held on Thursday, February 26, 2009, from 5:00 p.m. to 6:30 p.m. in the Grand Ballroom of the Kelly Inn in downtown St. Cloud. The panel will feature four experts on the local, state, national and international economies – Dan Laufenberg, Chief Economist at Ameriprise Financial, Tom Stinson, Minnesota State Economist, Steve Hine, Labor Market Information Director at the Minnesota Department of Employment and Economic Development, and King Banaian, Professor and Chair of the Economics Department at SCSU.
