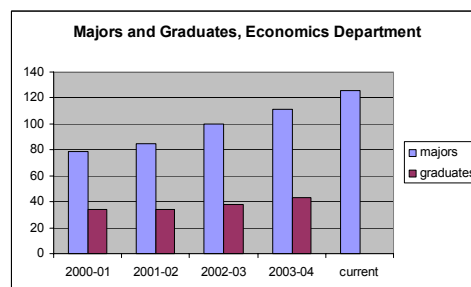

ALUMNI NOTES

- **Johnathan Mercer** was one of approximately 175 students from 15 countries chosen to attend an annual international business conference sponsored by Business Today, Princeton University, on Nov. 20-23 in New York, N.Y. The SCSU student was chosen from an applicant pool of more than 2,000 students from around the world.

During the conference Mercer will discuss and debate government and business issues with executives from more than 70 Fortune 500 companies and political leaders from around the world. Among them will be the CEO of Continental Airlines, Inc.; a former chairman of the Federal Deposit Insurance Corporation; and the CEO of UPS. Past attendees have included Ralph Nader, the COO of the New York Stock Exchange, the founder and CEO of Def Jam Records, and Thomas “Mac” McClarty, chief of staff under President Clinton.

Business Today, a student organization started by Steve Forbes in 1968 during his time at Princeton, seeks to bring business and political leaders together with students to engage in open dialogue. Business Today publishes a biannual magazine, the largest student-run publication in the country, with a readership of 250,000. This is the 30th annual international conference sponsored by the group. The theme this election year is “The Interplay of Business & Politics.”

Mercer, who is majoring in business economics and computer science, will complete his degree in 2006. He is founder and CEO of Xumbrus (www.xumbrus.com), an educational software company that provides academic writing

software (www.scholarword.com) to more than 20,000 students worldwide. After three years, the company has been listed on websites like Apple.com, where it is recognized as having the “most popular” learning software title.

- Our students are scattered in many places: **Scott Bushee**, for example, was last seen managing a WalMart in Alaska; **David Stein** is now president of BankOne in Green Bay; **Liz (Stillman) Kulzer** is in Minneapolis working on the employment cost index for the Bureau of Labor Statistics; **Julie Williams** is building a financial planning practice for Waddell and Reed in Sioux Falls, South Dakota. - The **43rd Annual Winter Institute on Economic Outlook** is scheduled for March 15, 2005. This year’s program features **Dr. Ruby Payne**, well-known author of *A Framework For Understanding Poverty* (over 700,000 copies sold) and *Hidden Rules of Class at Work*. Plans are currently underway to feature another high profile speaker as well. Mark your calendars for 11:30 a.m. on March 15 for an alumni luncheon with our guest speakers and other invited guests to be followed by the speaker program in Ritsche Auditorium on the SCSU campus.
