FROM THE CHAIR

One of my jobs as chair is to advise students. We have so many that we will now have two faculty members assist me next year (Eric Hampton and Dan Gallagher) but up to now I have been the point of contact for people thinking about majoring in economics, the majors, and for many alumni.

A couple of months ago a student asked me if I kept a file of what our graduates say was helpful to them about our program in their careers and lives. "I did not," I said, "but I have e-mail addresses for about 75 alumni, so I could ask them to email you. Would that be helpful?" We agreed to try it, and later that day I shot an e-mail out asking for replies.

Örn Bodvarsson and his co-author, Hendrik Van den Berg (University of Nebraska-Lincoln) signed a contract with Springer to publish their book, *The Economics of Immigration: Theory and Policy.* Expected publication date is early 2008.

Örn Bodvarsson presented a paper, "Customer Discrimination, Capital Investment, and Sports Stadiums," (co-authored with Brad Humphreys) at the Midwest Economics Association conference in Minneapolis in March.
