Professor **King Banaian** is back teaching since ending his time as chair in July 2010. Running for the state representative seat in the MN 2010 election, he won by a very narrow margin. He serves in St. Paul in spring and teaches in summer and fall. "It has been fun to be back with students full-time again, and I have been trying out some new courses based on what I'm learning as a legislator," King said. This included teaching urban economics for the very first time this fall. "Cities are fascinating, and St. Cloud's economic history and development is particularly an interest of mine. My graduate research examined the change in Afghan opium production due to political conflict affecting Europe's heroin market and government policies. This research used an econometric model to reveal the supply and demand of heroin in 36 different countries from the Middle East to Western Europe in 2008 predicting socioeconomic consequences. Other research projects at Michigan Tech included an analysis of U.S. violent crime rates and restructuring the implementation of U.S. energy subsidies. SCSU developed my understanding and application of economic theory and econometrics. Working with Dr. Switzer on movie industry research was a tremendous benefit. The way I interpret information can be derived from receiving intuitive and progressive education, inspiring my graduate research and career. This was vital to my graduate studies and put me ahead of other individuals seeking employment."
