WINTER INSTITUTE

The 53rd Winter Institute will be held on February 18 and 19, 2015.

The Keynote Speaker on the 19th will be Professor David Levinson, who will present "The Transportation Experience: From Steamboats to Streetcars." His talk will explore the historical evolution of transportation modes and technologies with an array of examples which supports the idea that modern policies are built from past experiences.

Professor Levinson serves on the faculty of the Department of Civil, Environmental, and Geo-Engineering at the University of Minnesota and as Director of the Networks, Economics, and Urban Systems (NEXUS) research group. He holds the Richard P. Braun/CTS Chair in Transportation. He also serves on the graduate faculty of the Applied Economics and Urban and Regional Planning programs at the University of Minnesota.

The Fall Semester 2015 presents a great opportunity for economics majors and minors to study at the SCSU site in Alnwick, Northumberland, England. Economics professor Rich MacDonald will serve as the SCSU faculty member (teaching Principles of Macroeconomics (ECON 205), Principles of Microeconomics (ECON 206), Money and Banking (ECON 471), and Contemporary Economic Problems: The British Economy (ECON 483)). Professor Michelle Kukoleca Hammes of the Political Science Department will be directing the Fall 2015 Alnwick program and will be teaching a course in political science. As usual, students will also take classes from British faculty on British History and Contemporary Britain. Students from across campus are encouraged to apply for the program. The focus of the program on economics and political science should be attractive to students from the School of Public Affairs (SOPA). SOPA students may count these courses toward their major/minor, continue fulfilling Liberal Education Program requirements, or apply the courses to the British Studies minor. Drs. Kukoleca Hammes and MacDonald look forward to integrating student experiences across all courses and applying a common public affairs perspective.
