Sauer earned her doctorate in economics from the University of Colorado at Boulder. She also holds a certificate in change leadership from Cornell University. Sauer extensively speaks at events across the country and has been recognized for her scholarly contributions to the advancement of teaching and learning. Sauer is an alumna of the University of Colorado Excellence in Leadership Program and a former fellow of the TIAA Institute and the Center for Research on Consumer Financial Decision-Making. Her community engagement activities have included work as a Court Appointed Special Advocate (CASA) for abused and neglected children, an independent county election judge, and a volunteer yoga and meditation instructor.
